Terms & Conditions for Conversion of Fly ash into Fly ash bricks

1. Brick manufacturer(s) need to supply 02 lac fly ash bricks, free of cost within 01 year from the date of agreement to the BPSCL site in lieu of fly ash supplied to them to the tune of 05 times as required for manufacturing of 02 lac bricks.
2. The additives required for manufacturing of bricks are to be arranged by the brick manufacturer at their own cost.
3. BPSCL may engage more than 01 fly ash brick manufacturer for conversion of fly ash into fly ash brick.
4. During agreement period only the agreed quantity will be provided to the brick manufacturer.
5. BPSCL & interested fly ash brick manufacturer will go into an agreement for supply of fly ash by BPSCL and supply of fly ash brick by fly ash brick manufacturer.
6. The validity of agreement period will be one (01) year from the date of commencement of fly ash transportation.
7. **BPSCL Responsibility :**
 - 6.1 Supply and transportation of fly ash from Unit#9 silo to the brick manufacturer's site, free of cost.
 - 6.2 Co-ordination at BSL gate for entering the bricks loaded vehicle into plant premises and returning of empty vehicle.
8. **Fly ash Brick manufacturer's Responsibility :**
 - 7.1 Unloading of fly ash at fly ash brick manufacturer site.
 - 7.2 Manufacturing, loading, transportation, unloading of fly ash brick at BPSCL site
9. The fly ash brick manufacturer will be fully responsible for any sort of unsafe activity of their workmen in manufacturing, loading, transportation & unloading of fly ash brick.
10. The party will be fully responsible for any sort of unsafe activity caused by the vehicle engaged in loading, transportation & unloading of fly ash brick.
11. In the event of any work-accident, major or minor, of persons involved in manufacturing, loading, transportation & unloading of fly ash bricks, party must take care of the injured person immediately and provide him / them the required treatment as suggested by the Registered Doctor. The injured person may be admitted to BGH for the treatment by paying the charges as demanded by the hospital authority.
12. Party will ensure that their workmen wear all the PPE like hand gloves, safety helmet, safety shoes, Nose Mask, Safety goggles, etc. during manufacturing, loading, transportation & unloading of fly ash bricks.
