- 1. The bidder should have minimum average annual turnover (MAT) of **Rs. 35.85 Lakh** only.
  - Average annual turnover shall be determined taking into consideration turnover of preceding three (03) consecutive financial years. Other income shall not be considered for arriving at annual turnover.
  - Audited annual account along with auditor's report of the bidder should be furnished in support of the same. Where audited account is not mandatory as per the law, the bidder has to submit annual financial turnover during the consecutive last three (03) years ending 31<sup>st</sup> March of the previous financial year duly certified by CA.

## 1.02 Tender Validity Period

Validity of the offer shall be **Four (04) months** from the bid opening date. In case of extension of "Bid submission & Opening Date", the validity will be counted from the extended bid opening date.

#### 1.03 General Instructions:

- i) You shall clearly indicate that your prices shall remain firm in all respects till execution of the order.
- ii) Specification, quantity, unit rate, freight, insurance, packaging, forwarding, taxes etc. should be mentioned separately and clearly.
- iii) Any conditional offer or offer having deviations is liable to be rejected.
- iv) Where agent commission is involved the same is to be indicated in percentage.

2.01 BPSCL reserves the right to ask for original documents for verification at any time during tendering, evaluation and / or the execution of the contract. In case any documents / information submitted by you is / are found to be false or containing any misrepresentation or having any fraudulent declaration in it, then, in such eventuality, legal action (including cancellation of contract, banning of business dealing, criminal proceedings etc.) as deemed fit may be initiated by BPSCL against you.

## 2.02 **Packing:**

- a) **Responsibility for proper packing** You shall be responsible for the materials being sufficiently and properly packed, for transport by rail / road / sea / air / any combination of above, so as to ensure their being free from loss or damage on arrival at the destination.
- b) Marking of Packages, Packing, etc. Each package delivered under the contract shall bear the following:-
  - Name of the Supplier
  - Contract/Order Number
  - Consignee's name and address
  - Description and quantity of contents
  - Gross weight, net weight,
  - Distinctive number or mark which is also to be shown, for the purpose of identification, on the Supplier's packing list.
  - Catalogue Number
- 2.03 **Delivery:** Timely delivery is the essence of the contract & must be completed as per the dates specified therein.
- 2.04 **Liquidated Damages:** In the event of supply not being effected within the contractual delivery schedule given in the order, excluding the time taken by BPSCL in approval of the drawings submitted by you, liquidated damages @ ½ % of the value of delayed materials for each week of delay and part thereof, subject to a maximum of 05% of the total order value shall be recovered from you. The deduction of such damages shall not relieve you from the contractual obligations to complete the supply as stipulated in the Contract.
- 2.05 **Risk Purchase**: If you fail to deliver the material either in full or in part, within the prescribed delivery period, BPSCL shall be entitled at its option to take alternate procurement action, at your risk & cost for the unsupplied portion of the goods / items for which delivery period has expired.
- 2.06 You must mention applicable GST rate in your offer with compliance of following GST clauses:
  - a) You shall have to quote GST as extra. If not mentioned, same will be considered as EXTRA.
  - b) You shall have to pass on the tax benefit/savings, if any, on account of output taxes to BPSCL.
  - c) You shall agree to do all things not limited to providing GST invoices or other documentation as per GST Law relating to the above Services, payment of taxes, timely filing of valid statutory returns for the tax period on the Goods and Service Tax Portal etc. that may be necessary to match the invoice on GSTN common portal and enable BPSCL to claim input tax credit in relation to any GST payable under this agreement or in respect of any part under this agreement.
  - d) In case the Input Tax Credit of GST is denied or demand is recovered from BPSCL on account of any non-compliance by you, including non-payment of GST charged and recovered, you shall indemnify BPSCL in respect of all claims of tax, penalty and/or interest, loss, damage, costs, expenses and liability that may arise due to such non-compliance. Further, in case of any differential tax liability on account of any wrong classification/valuation etc. by you, BPSCL will not be liable to reimburse any part of such differential tax, interest, penalty etc. It will be your sole responsibility to discharge appropriate taxes, as applicable.

- 2.09 <u>Inspection</u>: Acceptance of material is subject to inspection. Final Inspection will be done at BPSCL Stores after receipt of material.
- 2.10 **FORCE MAJEURE:** You shall not be considered in default if delay occurs due to reason beyond your control such as acts of God, natural calamities, civil wars, fire, strike, frost, floods, riot and acts of unsurpassed power. Only those causes which have duration of more than seven days shall be considered in force majeure clause. In the event of delay due to such clause the delivery period will be extended for a length of time equal to the period of force majeure at the option of BPSCL. Order may be cancelled without any liability what so ever on the part of BPSCL.
- 2.11 **Banning of Business Dealings:** On arising of any situation or occurrence of any event as mentioned in Clause 6 of the Guidelines on Banning of Business Dealings, you shall be liable for action under and in accordance with the aforementioned Guidelines. Application: Used as Grinding Media for pulverising coal in Ball & Tube Mills.

**Standard:** Specification in general must comply with BS 4844 Gr 3 F & IS 1586 with the following additional requirements:

### 1. Chemical Composition:

a) The heat analysis shall conform to the following composition:-

- b) The carbon content shall be aimed at lower range so as to get better toughness and impact resistance.
- c) Chromium/ Carbon (Cr/C) ratio shall be maintained at 5.0 minimum adhering to range specified for both the elements.
- **2. Hardness:** Minimum 57 RC. The hardness measurements shall be carried out on the surface at the depth of minimum 3 mm below the original surface of the balls.
- **3. Retained Austenite:** Maximum 15 %.
- **4. Micro Structure:** Wholly tempered martensitic with trigonal (Fe-Cr)<sub>7</sub>C3 type finely dispersed complex carbides.

## 5. <u>DIMENSIONS AND TOLERANCES:</u>

**Tolerance:** The tolerances on nominal diameter of the balls shall be as follows:-

- **6. Manufacture:** The material shall be melted in induction furnace.
- 7. **Heat Treatment: Suggested** heat Treatment Cycle are:
- a) Hardening: Heating slowly upto a temperature of 850-950 °C hold for 1-2 hours, followed by air cooling or quenching in oil.
- b) Tempering: Heating slowly up to a temp of 200-350 °C hold for a suitable time to the section size and cool in still air of furnace.

- c) However, the actual heat treatment cycle is to be established by means of process qualification to meet requirement of hardness & microstructure specified herein above.
- 8. Finish: All castings shall be properly fettled, tumbled & dressed. All surfaces shall be thoroughly cleaned
- **9.** <u>Freedom from defects:</u> The casting shall be free from defects such as blow holes, sand inclusions, shrinkage cavities, cold shuts, cracks etc. which may adversely affect the utility of castings.

- b) Extra ingate or depression at ingate location is more than  $\pm$  1.0 mm over the dimensional tolerances specified for the respective sizes.
- c) Ovality more than 10 % for 30 mm Grinding media, 7.5 % for 40 mm grinding media and 7% for 50 mm grinding media.
- d) Ovality is defined as <u>Maximum Diameter Minimum Diameter</u> X 100 Effective diameter

Ovality also includes de-shaping due to parting line flashes

### 11. Mechanical Properties:

**Micro Examination:** The micro structure of the balls after the heat treatment shall reveal carbides and tempered martensite. The retained austenite content shall not exceed 15 % (to be aimed as low as possible).

## 12. <u>Test Samples for in Process Inspection:</u>

- a) Each melts shall be analysed for chemical composition.
- b) The hardness shall be measured on 5 balls selected at random from each treatment batch.
- c) One ball shall be selected randomly from each heat treatment batch for micro examination.
- d) Dimensional check shall be carried out by means of templates (Go and No Go Types). The templates shall be designed and manufactured by the supplier.

- b) <u>Chemical Analysis:</u> 5 Balls Selected from a batch of 8 drums for Chemical composition and shall conform to requirement given at Chemical composition clause. If any of these balls fall to meet the chemical composition clause then the entire batch of 8 drums will be rejected.
- c) Hardness Test: The sampling method for hardness test shall be as follows:-
  - A batch consisting of 8 drums of balls shall be selected and 10 balls from these drum be tested for hardness requirement. If any of these 10 balls fail to meet the hardness requirement, 10 more balls shall be tested.
