b) Audited annual accounts along with auditor's report of the bidder should be furnished in support of the same. Where audited annual account is not mandatory as per the law, the bidder has to submit annual financial turnover during the consecutive last three (03) years, ending 31<sup>st</sup> March of the previous financial year duly certified by CA.

#### II. Technical Capability:

- Bidder should have experience of having completed similar work in India in any Public Sector Undertaking / Government / Semi Government organization or joint venture thereof / Company registered under Companies Act during last 7 years ending last day of month previous to the one in which offers are invited. Value of such work order shall be either of the following:
  - Three similar completed works each costing not less than to Rs. 84.36 Lakhs
     OR
  - b) Two similar completed works each costing not less than to **Rs. 105.45 Lakhs** OR
  - c) One similar completed work costing not less than to Rs. 168.73 Lakhs

Similar Work means work order / orders having AMC (Mechanical) of Pulverized coal fired Boiler of at least 220 TPH capacity and Steam Turbine of not less than 36 MW of single unit each capacity & their auxiliaries. The total value of the contract executed by the bidder for AMC (Mechanical) of Boiler & Turbine ,even in separate work orders in last Seven (07) years will be combined together and one work order each for Boiler & Turbine will be considered as one set .

**Completed Work** means the executed / completed portion of Work Order / Annual Maintenance Contract / Rate Contract, even if the work has not been completed in totality (subject to furnishing proof of executed value of work in the form of certified copies of RA Bills) along with successful work execution certificate (by the concerned authority).

- 2. Credential as subcontractor will not be considered.
- In support of their eligibility and experience, the bidder is required to submit self-attested photo
  copies of work orders & completion certificates (by the concerned competent authority) along with
  the techno-commercial bid.

Consortium Requirements: Not applicable for this tender.

#### 11. Other Conditions / Instructions

- a) If a Bidder withdraws its bid after opening of bids without giving any satisfactory and acceptable explanation thereof, the Bidder shall be debarred from participating in any tender of BPSCL for a minimum period of 01 (one) year.
- b) Bidder has the option of visiting the work site for actual assessment of the job before submission of offer.
- c) Any conditional offer or offer having deviations is liable to be rejected.
- d) Bidder is advised to mention page number on each page of documents submitted by him / her. BPSCL

- shall not bear any responsibility in case of any loss of documents submitted by the bidder during tender opening or thereafter.
- e) If the Bidder is a Firm or Company, then it shall, in the forwarding letter, mention the number and names of all the partners & shall sign before submitting the same, unless the Power of Attorney holder has specifically been authorized in this respect.
- Price or any indication of price shall NOT be mentioned in the Techno-Commercial Bid.
- g) The tenders received will be opened on scheduled opening date and time in the office of Material Management, in presence of such bidders who might choose to witness the same
- h) In case the date of tender opening happens to be a holiday, the tender will be opened on the next working day at the same time.
