6. Qualifying Requirements / Eligibility Criteria

The Bidder (*Manufacturer or Principal of authorised representative or Supplier– hereinafter referred simply as 'The Bidder'*) should meet Qualifying Requirements (QR) stipulated hereunder:

I. Financial Capability:

1. Bidder should have Minimum average annual turnover (MAT) of **Rs. 6.08 Lakhs** in preceding three (03) Consecutive Financial years.

Audited annual accounts along with auditor's report of the bidder should be furnished in support of the same. Where audited annual account is not mandatory as per the law, the bidder has to submit annual financial turnover during the consecutive last three (03) years, ending 31st March of the previous financial year duly certified by CA.

Note: Average annual turnover shall be determined taking into consideration turnover of preceding three consecutive financial years. Other income shall not be considered for arriving at annual turnover.

II. Technical Capability:

 The bidder should have requisite experience of manufacturing OR supplying "Hydrogen Gas", in India to any PSU / Government / Semi Government Organization or Joint Venture thereof / Company registered under Companies Act.

The bidder is required to submit self-attested copies of Purchase Orders, GRN / Delivery Challan / Completion Certificate etc. as proof of supply in support of their eligibility and experience.

2. If the bidder is:-

- a) **Manufacturer**: He has to submit Manufacturer Certificate as a proof of Hydrogen Gas manufacturing along with proof of supply.
- b) Authorized Representative: He has to submit authorization certificate from manufacturer and a proof of Hydrogen Gas manufacturing of authorizing manufacture, along with proof of supply to quote in the tender
- c) **Supplier**: He has to submit dealership certificate from the manufacturer and a proof of Hydrogen Gas manufacturing of the manufacturer, along with proof of supply to quote in the tender.
