6. Qualifying Requirements / Eligibility Criteria

The Bidder (*Manufacturer or Principal of authorised representative or Supplier– hereinafter referred simply as 'The Bidder'*) should meet Qualifying Requirements (QR) stipulated hereunder:

I. Financial Capability:

1. Bidder should have Minimum average annual turnover (MAT) of **Rs. 17.44 Lakhs** in preceding three (03) Consecutive Financial years.

Audited annual accounts along with auditor's report of the bidder should be furnished in support of the same. Where audited annual account is not mandatory as per the law, the bidder has to submit annual financial turnover during the consecutive last three (03) years, ending 31st March of the previous financial year duly certified by CA.

Note: Average annual turnover shall be determined taking into consideration turnover of preceding three consecutive financial years. Other income shall not be considered for arriving at annual turnover.

II. Technical Capability:

 The bidder shall have requisite experience of manufacturing OR supplying of Terminal Bushings for Turbo Generators' having capacity of 55 MW and Voltage Level 11.5 kV or more in India to any Public Sector Undertaking / Government / Semi Government Organization or joint venture thereof / Company registered under Companies Act.

The bidder is required to submit self-attested photo copies of Purchase Order (s) in support of their eligibility/experience & satisfactory performance certificate (s) of supplied Terminal Bushing over a period of last 01 (One) year (at least), for which purchase order (s) has been submitted by the bidder.
