#### 6. Qualifying Requirements / Eligibility Criteria

The Bidder (*Manufacturer or Principal of authorised representative*— *hereinafter referred simply as* '*The Bidder*') should meet Qualifying Requirements (QR) stipulated hereunder:

#### I. Financial Capability:

1. Bidder should have Minimum average annual turnover (MAT) of **Rs. 324.93 Lakhs** in preceding three (03) Consecutive Financial years.

Audited annual accounts along with auditor's report of the bidder should be furnished in support of the same. Where audited annual account is not mandatory as per the law, the bidder has to submit annual financial turnover during the consecutive last three (03) years, ending 31st March of the previous financial year duly certified by CA.

**Note:** Average annual turnover shall be determined taking into consideration turnover of preceding three consecutive financial years. Other income shall not be considered for arriving at annual turnover.

#### II. Technical Capability:

 The bidder should have requisite experience of manufacturing AND supplying "Heat Exchangers of Boilers like Economizer panel/ Super Heater panel/ Air Preheater/ Water Wall panel, Reheater panels of Boiler having minimum capacity of 220 T/ Hour", in India to any PSU / Government / Semi Government Organization or Joint Venture thereof / Company registered under Companies Act during the last seven (07) years from the date of NIT, in which offers are invited

The bidder is required to submit self-attested copies of documents (Orders, GRN / Delivery Challan / Completion Certificate) as proof of supply in support of their eligibility and experience.

 Bidder shall have valid ISO 9001 certification for manufacturing Heat exchangers of Boilers like Economizer panel/ Super Heater Panels/ Air Preheaters/ Water Wall Panels/ Reheater Panels, as on Bid Opening Date.
