6. Qualifying Requirements / Eligibility Criteria

The Bidder (Manufacturer or Principal of authorized dealer or Supplier – hereinafter referred simply as 'The Bidder') should meet Qualifying Requirements (QR) stipulated here under:

I. Financial Capability:

1. Bidder should have Minimum average annual turnover (MAT) of Rs. 26.66 Lakhs in preceding three (03) Consecutive Financial years.

Audited annual accounts along with auditor's report of the bidder should be furnished in support of the same. Where audited annual account is not mandatory as per the law, the bidder has to submit annual financial turnover during the consecutive last three (03) years, ending 31st March of the previous financial year duly certified by CA.

Note: Average annual turnover shall be determined taking into consideration turnover of preceding three consecutive financial years. Other income shall not be considered for arriving at annual turnover.

II. Technical Capability:

- 1. The bidder shall have requisite experience of Manufacturing or Supplying of "Similar items" in India to any Public Sector/Government/Semi Government Organization or Joint Venture thereof/Company registered under Companies Act:
 - "Similar items" means: VPI Motors having Capacity of 2000 kW or more and Voltage grade of 6.6 kV or more.
- 2. The bidder is required to submit self-attested photocopies documents i.e. Purchase Orders, GRN/ Delivery Challan / Completion Certificate (by the concerned authority etc.) in support of their eligibility and experience along with the techno-commercial bid. In addition, the bidder has to submit and affidavit as per format at Annexure -II, declaring that the documents submitted under my knowledge and are authentic, genuine and true. No part of the document(s) / information is false, forged or fabricated.
