#### 6. Qualifying Requirements / Eligibility Criteria

#### I. Financial Capability:

 Bidder should have Minimum average annual turnover (MAT) of Rs. 19.51 Lakhs in preceding three (03) Consecutive Financial years.

Audited annual accounts along with auditor's report of the bidder should be furnished in support of the same. Where audited annual account is not mandatory as per the law, the bidder has to submit annual financial turnover during the consecutive last three (03) years, ending 31st March of the previous financial year duly certified by CA.

**Note:** Average annual turnover shall be determined taking into consideration turnover of available preceding three consecutive financial years. Other income shall not be considered for arriving at annual turnover.

#### II. Technical Capability:

- The bidder should have requisite experience of manufacturing / supplying "Similar items", in any PSU / Government / Semi Government Organization or Joint Venture thereof / Company registered under Companies Act.
- 2. In support of their eligibility and experience, the bidder is required to submit self-attested copies of (Purchase orders, completion certificates, tax invoices ,GRN , delivery challan, e-way bill etc ) along with techno-commercial bid as proof of supply in support of their eligibility and experience.
- 3. In case of any documents/ information submitted by the bidder(s) is found to be false or containing any misrepresentation or having anything fraudulent in it, then in such eventuality legal action (including cancellation of contract, banning of business dealings, damages, criminal proceedings etc.) as deemed fit may be initiated by BPSCL against the bidder.
