Audited annual accounts along with auditor's report of the bidder should be furnished in support of the same. Where audited annual account is not mandatory as per the law, the bidder has to submit annual financial turnover during the consecutive last three (03) years, ending 31st March of the previous financial year duly certified by CA.

Note: Average annual turnover shall be determined taking into consideration turnover of preceding three consecutive financial years. Other income shall not be considered for arriving at annual turnover.

II. Technical Capability:

1. The bidder should have requisite experience of Manufacturing and Supplying of **"Similar items"** in India to any Public Sector/Government/Semi Government Organization or Joint Venture thereof/Company registered under Companies Act:
