Bokaro Power Supply Company (P) Ltd. (BPSCL), A Joint Venture Company of Steel Authority of India Ltd. (SAIL) and Damodar Valley Corporation (DVC), situated in Bokaro Steel City, Jharkhand, invites online digitally signed e-bids in Central Public Procurement Portal (CPPP) (using Class-II or above Digital Signature Certificate) for the referred work in Power Plant of BPSCL.

Bidder shall not tamper / modify the tender document / form including downloaded price bid template in any manner. In case the same is found to be tampered / modified in any manner, bid will be rejected and EMD will be forfeited and Bidder shall be liable to be banned from doing business with BPSCL for a suitable period as per policy of BPSCL.

Qualifying Requirements / Eligibility Criteria	<p>Financial Capability:</p> <ol style="list-style-type: none">Bidder should have Minimum average annual turnover (MAT) of Rs. 110.20 Lakhs in preceding three (03) Consecutive Financial years. <p>Note:</p> <ol style="list-style-type: none">Average annual turnover shall be determined taking into consideration turnover of preceding three consecutive financial years. Other income shall not be considered for arriving at annual turnover.Audited annual accounts along with auditor's report of the bidder should be furnished in support of the same. Where audited annual account is not mandatory as per the law, the bidder has to submit annual financial turnover during the consecutive last three (03) years, ending 31st March of the previous financial year duly certified by CA.

Technical Capability:

2. The bidder should be owner/freehold or leasehold of the earth moving equipment (Dozer – BD 155 (320 HP) or equivalent) to be deployed and ownership document/leased agreement of possession should be furnished. The date of first purchase from the manufacturer or their authorized dealer/agency of the offered earth moving equipment (Dozer) shall not be more than five (05) years from the BOD.

OR

In case the bidder intends to hire the earth moving equipment (Dozer – BD 155 (320 HP) or equivalent) to be deployed, bidder shall be in agreement with the owner of the equipment in this regard. The agreement shall clearly mention that the owner of the equipment shall, in the event of placement of order on the bidder against the NIT, hand over the earth moving equipment (Dozer) to the bidder within a period of 07 days from the date of order. Copy of the agreement of hiring along with ownership documents of the equipment shall be furnished with the techno-commercial bid. The date of first purchase from the manufacturer or their authorized dealer/agency of the offered earth moving equipment (Dozer) shall not be more than five (05) years from the BOD.

Note for SI. No.2 above:

- a. In case of requirement for more than one earth moving equipment (Dozer), ownership document/leased agreement/agreement of hiring with ownership document, as the case may be, should be furnished for all the equipment.
 - b. The bidder should furnish the document mentioning the year of manufacturing of the offered equipment.
3. Bidder should have experience of having completed similar work in India in any Public Sector Undertaking / Government / Semi Government organization or joint venture thereof / Company registered under Companies Act during last 7 years ending last day of month previous to the one in which offers are invited. Value of such work order shall be either of the following:

Note for SI. No.3 above:

- a) Three similar completed works each costing not less than to **Rs. 146.93 Lakhs**
OR
- b) Two similar completed works each costing not less than to **Rs. 183.67 Lakhs**
OR
- c) One similar completed work costing not less than to **Rs. 293.87 Lakhs**

Similar Work means Any type of work executed by earth moving equipment (Dozer / Pay Loader / Excavator – single or in combination) in any industry / organization within India.

In case of composite work order consisting of any type of work executed by earth moving equipment (Dozer/Pay Loader/Excavator), the total value of work order shall be considered.

Note:

- i. Completed Work means the executed / completed portion of Work Order / Annual Maintenance Contract / Rate Contract, even if the work has not been completed in totality (subject to furnishing proof of executed value of work in the form of certified copies of RA Bills) along with successful work execution certificate (by the concerned authority).
- ii. Partially completed work orders having validity of more than one year shall be considered for Technical Evaluation conforming to the definition of Similar Nature Work in the work order for assessment of eligibility as per Eligibility Criteria if the Bidder has completed at least 01 (one) year of the period of the work order.
- iii. Work Order, whose total work duration is one year or less than one year, will only be considered for Technical Evaluation if work execution against the same has been completed in totality.

	<p>iv. Completed Sub-orders issued against Rate Contract shall be considered after completion of 01 (one) year period of that Rate Contract. All Sub-Orders completed by a bidder under one Rate Contract will be considered as single work order for evaluation as per Eligibility Criteria.</p> <p>3.1 In support of their eligibility and experience, the bidder is required to submit copies of work orders & completion certificates (by the concerned competent authority) along with the techno-commercial bid.</p> <p>Consortium Bidding: Not allowed for this tender.</p>
